

PLUMAS PINES WOMEN'S GOLF CLUB

LOCAL RULES 2021

- OUT OF BOUNDS:** DEFINED BY WHITE STAKES AND WHITE CHAINS. INSIDE COURSE, OUT OF BOUNDS LEFT ON HOLE #18. DRIVING RANGE, HOLES #1 AND #9, ARE OUT OF BOUNDS. HOLE #5 LEFT SIDE OF FAIRWAY, AND HOLE #15 LEFT SIDE OF GREEN; WHERE CHAINS ARE USED ALONG WITH POLES. TO DESIGNATE OUT OF BOUNDS, IF YOUR BALL IS IN BOUNDS BUT YOUR SWING IS INHIBITED BY THE CHAINS (NOT POLES) YOU MAY TAKE 1 CLUB LENGTH DROP, NO CLOSER TO THE HOLE, WITH NO PENALTY.
- NOTE: PPWGC CHOSE NOT TO ADOPT THE OPTION TO DROP IF A BALL IS HIT OUT OF BOUNDS. THE STROKE AND DISTANCE RULING, USGA RULE #18, WILL APPLY ON A BALL HIT OUT OF BOUNDS. TO SAVE TIME, HIT A PROVISIONAL BALL.**
- WATER HAZARDS:** DEFINED BY YELLOW STAKES.
- LATERAL WATER HAZARDS:** DEFINED BY RED STAKES.
- HAZARD MARGINS:** MARGINS OF WATER HAZARDS (YELLOW STAKES) AND LATERAL WATER HAZARDS (RED STAKES) ARE DEFINED BY AN IMAGINARY LINE CONNECTING THE STAKES.
- GPS DEVICES:** PLAYER MAY OBTAIN INFORMATION FROM USING A DEVICE, SUCH AS A GPS, THAT MEASURES DISTANCE ONLY.
- CHALKED AREAS:** FREE DROP - NO CLOSER TO THE HOLE.
- HOLE #3:** POND IS MARKED WITH BOTH YELLOW AND RED STAKES.
- HOLE #6:** THERE IS OUT OF BOUNDS BEYOND THE CART PATH IN BACK OF THIS GREEN. IF YOU ARE IN DOUBT WHETHER YOU ARE IN BOUNDS, YOU MAY HIT A PROVISIONAL BALL
- HOLE #7:** THERE IS OUT OF BOUNDS LEFT AT THE ROAD.
- HOLE #8:** OUT OF BOUNDS BETWEEN THE POND ON THE RIGHT AND THE CONDOS.
- HOLE #10:** **THE PLAYER HAS THE OPTION TO CROSS TO THE DROP AREA AFTER HITTING TWO BALLS IN THE WATER. PROCEED TO DROP AREA. THE SCORING WILL BE AS FOLLOWS: FIRST SHOT IN THE WATER, 1 STROKE PLUS 1 STROKE PENALTY, SECOND SHOT IN THE WATER 1 STROKE, CARRY BALL TO DROP AREA 1 STROKE PENALTY (ADD TO FINAL SCORE FOUR STROKES). IF PLAYER OPTS TO CROSS TO THE DROP AREA AFTER ONLY ONE SHOT IN THE WATER, SHE MUST TAKE THE FULL FOUR STROKES. AT THE DROP AREA, SHE WILL BE HITTING FIVE, PLUS ANY SHOTS IT TOOK TO REACH THE POND. Drop area on #10 is across bridge, right side of cart path.**
- HOLE #12:** OUT OF BOUNDS ON THE RIGHT OF THE FAIRWAY WHERE THE RESIDENTIAL LOTS BEGIN. YOU MAY WANT TO HIT A PROVISIONAL BALL TO SAVE TIME.
- HOLE #13:** SEE HOLE #10. Drop area on #13 is across pond, on right side of path between path and pond on curve in path.
- HOLE #14:** THERE ARE HAZARD STAKES AND OUT OF BOUNDS TO THE RIGHT OF THE FAIRWAY. HIT A PROVISIONAL BALL TO SAVE TIME.
- HOLE #15:** YOU GET A FREE DROP IF YOU LAND IN THE BARK AROUND THE TREE UP BY THE GREEN NO CLOSER TO THE PIN. WOODS TO THE RIGHT ARE A LATERAL HAZARD UNTIL SHORTLY BEFORE THE GREEN. BALLS HIT TO THE RIGHT BEYOND THE HAZARD STAKES COULD BE LOST AND A PROVISIONAL BALL SHOULD BE PLAYED.
- IMMOVABLE OBJECTS:** LOGS ON COURSE MARKING THE CART PATHS ARE AN IMMOVABLE MANMADE OBJECT. FREE DROP, ONE CLUB LENGTH.
